No. AH-M-10/08. 28309 /H., Bhubaneswar, dated 26-12-08

The Ayurvedic Medical Officers, Homeopathic Medical Officers and Unani Medical Officers of the State under the Director of Indian Medicines and Homoeopathy in Health and Family Welfare Department have been requesting the State Government for up gradation of their posts from Group-C to Group-B level and the same was under active consideration of Government for some time past.

Now, after careful consideration, Government have been pleased to order that the entry level for Ayurvedic Medical Officers, Homoeopathic Medical Officers and Unani Medical Officers would be in Group-B carrying the pre revised-scale of Rs. 6500-200-10,500/- and all the regular posts of Ayurvedic Medical Officers, Homoeopathic Medical Officers and Unani Medical Officers having pre revised scale of pay of Rs. 5500-175-9000/- will stand upgraded to the level of Group-B in the pre revised scale of pay of Rs. 6500-200-10,500/- .

This shall come into force from the date of issue of this Resolution.

This has been concurred in by the Finance Department vide their UOR .




